MOST STAINS CAN BE REMOVED BY WIPING CLEAN. • THE NEW GENERATION OF MICROFIBRE CLEANING CLOTHS ARE EXTREMELY EFFECTIVE WITHOUT SOAP FOR GENERAL CARE AND MAINTENANCE. • WIPE CLEAN REGULARLY WITH A DAMP CLOTH TO REMOVE DUST PARTICLES AND LIGHT SOILING. • REMOVE SPILLAGES PROMPTLY (WITHIN 15 MINUTES) WITH AN ABSORBENT DRY CLOTH. • FOR GENERAL SOILING, USE A SOFT BRUSH WITH CARE TO AVOID ABRASIVE DAMAGE TO SURFACE AND TEPID SOAPY WATER (NON-ALKALINE). RINSE CLEAN WITH CLEAR WATER. DRY WITH AN ABSORBENT CLOTH. • BODILY FLUIDS SHOULD BE REMOVED PROMPTLY (WITHIN 15 MINUTES) WITH COLD WATER AND THEN CLEANED AS ABOVE. • EXTREME SOILING/INFECTION CONTROL USE A 5% SODIUM HYPOCHLORITE (BLEACH) SOLUTION. • DO NOT MACHINE WASH OR DRY CLEAN • DO NOT APPLY OTHER CHEMICALS SUCH AS POLISH, SOLVENTS OR STAIN REMOVERS.
